Item 8. To discuss the success of the 'No Mow May' initiative.

Mixed feedback has been received by the Parish Council. 3 comments relating to the length of the grass making the play area unusable in the May school holiday and 1 from the contractor. A copy of the e-mail sent to the contractors for discussion at the meeting is copied below.

Thank you for cutting the play area today, the area in between the obstacle course was particularly bad I know as I was there with the children on Friday. You raise some good points about 'No Mow May';

1. Due to NO MOW MAY you have missed scheduled cuts on days you are mowing.

2. You have accounted quite a bit of upset from locals asking why you haven't cut it in May.

The Parish has had feedback from residents and from yourselves and it's been a mixed bag to be honest, if you've got anything to add please let me know. Councillors will consider whether to continue with 'No Mow May' in May 2024 at their meeting next month (4 July). In particular they will;

1. Comment on your question if leaving the grass has been beneficial for this period.

2. Note your comment What damage will be done to wildlife that has take up residence in that time?

3. Respond to your point That contractors (ie yourselves) should not have to deal with upset from locals why the grass hasn't been cut

4. Respond to your suggestion that posters explaining NO MOW MAY next time if this is to carry on

I note your comment Also it is now going to take a lot of work to get it back to how it was this not allowed for in original quote as MO MOW MAY was not implemented. Please advise if this means you will be asking the Parish Council to pay extra on top of the original quote - this will be important in the discussions too.


Nb the contractors invoice for this quarter has been received and there are no additional charges.
